NOTEWORTHY CASE ADVOCACY

State in the Interest of N.H., 226 N.J. 242, 141 A.3d 1178 (2016). Homicide. Trial attorney for N.H., demanded full and complete discovery prior to the transfer hearing. Although this was an unsettled area of the law, the Appellate and Supreme Court of New Jersey affirmed the trial court's decision. N.H. has been cited 42 times in cases seeking to expand and protect the rights of youth in juvenile court.

State in the Interest of B.D. Homicide. Trial attorney for B.D. charged in a Homicide at the age of 14. Retained national expert to prepare cross of the medical examiner. State dismissed the Homicide charge following cross of the medical examiner and offered a plea to assault for probationary sentence. Years later, I filed a motion to expunge the complaint from B.D.'s record. Following the expungement, B.D. applied to become a firefighter.

State in the Interest of F.S. Interlocutory Appeal of Youth Confidentiality. State moved to reveal my client's name, address and contact information to an alleged victim pursuing a civil complaint. Trial court granted the State's application. I filed an emergent appeal to the Appellate Division and received a stay. The State withdrew its application upon review of my filings.

State in the Interest of S.C. Modification of Sentence. Amid the COVID-19 crisis, I led a statewide effort to file modifications of sentences to have youth released from incarceration at our youth prison. S.C. was one of the youth who was resentenced and released from the care of the Juvenile Justice Commission.

State in the Interest of S.R. Denial of Motion for Waiver to Adult Court. Demonstrated that the State had abused its discretion in moving to have S.R. transferred to adult court for prosecution due to their failure to reinterview the main witness following my investigation which called into question her identification of S.R.

State in the Interest of S.C. Dismissal of Complaint for Delay of Prosecution/In the Interest of Justice. S.C. was charged in an aggravated sexual assault 20 years after the alleged incident date. The State of New Jersey filed the complaint and a hold while S.C. was serving a sentence in Pennsylvania. The State of New Jersey did not serve a copy of the complaint, nor did they respond to S.C.'s demands for information on the hold which prevented his parole. Despite S.C. being in his late 30s, I convinced the court that the juvenile court was the court of original jurisdiction, that the matter must be heard, confidentially, and that S.C. did not meet the criteria for pre-trial detention. Subsequently, the Court granted a motion to dismiss the complaint based on delay of prosecution and in the interests of justice.
