Highlights:

Over **\$64 million in gifts and pledges** secured since 2022, including a transformational naming gift of \$32.5 million from The Bill Gatton Foundation in 2025, which will be used entirely to provide student financial support, such as, funding of the law school’s most prestigious scholarship program—the Frank Winston Public Interest Law and Business Law Fellows—and recurring Frank Winston Law Grants to be awarded to 50 students in each year’s entering class.

Establishment of the **Appalachian Justice Research Center**, a transdisciplinary collaboration operated jointly by the College of Law and the College of Arts & Sciences, which brings together scholars and students from a wide range of disciplines across campus (e.g., Law, Sociology, Social Work, Health Sciences, Agriculture, and Architecture) to address longstanding intractable challenges faced by citizens in the Appalachian and Mountain South regions through engaged community-based research and learning.

Instituted **new first-year curriculum** in the fall of 2025 and led a successful effort to change the College of Law’s grading system, including the addition of a mandatory curve.

Enrolled the **highest credentialed entering classes** in the law school’s history during each year since 2022, culminating in 2025 with entering class statistics of **164 median LSAT** and **3.89 median GPA**.

Significantly **increased enrollment** in Winston Law’s **online Master of Legal Studies and Graduate Certificate Program**—the program started with **10 students** in the **fall of 2021**; that number has grown to **118 students** (commencement of **fall 2025 semester**).

Attracted **13 new faculty members**—8 tenure track and 5 non-tenure track—with a diverse range of teaching and scholarly expertise.

Successfully advocated for a **20% increase in tenure-track faculty salaries** since my arrival in 2022, which has substantially enhanced our recruitment and retention efforts.
